

## CATEGORY 2 – Landscaping or Outdoor Site Works PLAN APPROVAL MATERIALS REQUIRED

## 1. Payment of Fee

Cheque to be made payable to <u>British Pacific Properties Limited</u>. Refer to Plan Approval Instructions, Item 4 (Application Processing Fee – Fee Calculation Example).

## 2. Proof of Ownership

A copy of the current Title Search at the Land Titles Office.

## 3. Statement of Intent/Site Preparation

A written statement that indicates the nature of the proposed project, e.g. construction of a gazebo, installation of a fence, addition of a hot tub etc. Also all action that will be taken in preparing the site, e.g. grading and/or blasting, demolition and/or removal of buildings, and any significant elements that will be retained or disturbed i.e. buildings, driveways etc.

### 3. Existing Site Conditions

8½ x 11 photos showing site and adjoining properties with description of location.

### 4. Application and Agreement (Attachment A)

The form attached as Attachment A is to be completed and signed by the owner (if owned jointly, all owners must sign their names).

## 5. Materials List (Attachment B)

### 6. Colour Chip Sheet

Samples on 8 ½ x 11 sheet format (suitable for filing – no boards) demonstrating colours for all major elements and surfaces. Printed colour chips or those contained in plans are acceptable as long as they provide proper colour representation.

## 7. Legal Survey\*\*

A current legal survey of your property (11 x 17 or full size), prepared by a registered British Columbia Land Surveyor showing property lines and dimensions; existing natural topographical levels; rights-of-way and easements; site area; building envelope. The survey shall also indicate required British Pacific Properties Limited's setbacks at each floor level.

### 8. Detailed Plans\*\*

- 1. Appropriate plans, elevations and section prepared at a scale of 1/4" 1'0" or 1:50 for proposed work and affected areas.
- 2. Landscape plan, including plant list, drawing prepared at a scale of 1/8" + 1'0", or 1:100, outlining fences, pools, tennis courts, driveways/paths, retaining walls, decks, patios etc., planted areas and tree locations as may be affected by the proposed work.
- 9. Once final approval has been granted by the British Pacific Properties Limited approving authority, a letter will be issued for pick up. Applicable permits must be obtained from the District of West Vancouver.
